

wish to thank you for your confidence in me to serve for the Leighth time as president of this association. Over these years we have made many changes in our volunteer fire service. Some of the programs this association has implemented are as follows: Alabama became the thirtieth state to join the National Recruitment and Retention program. A request to the Public Service Commission to require power companies to provide a reduced power rate for the volunteer fire departments was successful in 1999. A program to place AEDs in North Alabama became a statewide project, which will be 85% complete by the end of 2002. This association received \$235,000 in grants to apply to this program. An additional grant from ADECA for \$300,000 was also awarded to the association for the AED program. The first Wild Land Fire Prevention Grant was issued to 104 departments or County Associations in 2001-2002. This association sponsored the Second National Fire Service Benefit Summit in March 2002, with 24 states attending.

Two programs approved by the association board failed to make the process. First, a statewide Public Relations recruiting program for the volunteers by Lewis Communications in Birmingham. The cost of this project was estimated to be \$100,000, funding for this program was pending. Second, funding to supplement departments whose annual income is less than \$10,000 per year. This project failed due to this association not getting a commitment for funding from ADECA or our state legislature. These two projects should have top priority of our board for the coming year. I plan to resubmit these projects to the AAVFD board at our next meeting.

Sherry Garner Memorial Award



Nominated by the Escambia County Volunteer Fire Association, Ginny Tyler was selected as the recipient of the 2002 Sherry Garner Memorial Award. As a member of Appleton VFD, she has a 95% turnout rate for all calls received by the department, the highest in the department.

Ginny assumed the duties of department training manager, organizing a system that tracks the qualifications and re-certification dates for all the firefighters in the department. She is the sole person responsible for acquiring a new brush truck for the department.

Ginny has been the key contact point for various fundraisers during the past year, which has included Appleton's Apple-Fest and two yard sales, raising over \$3,000 for the department. She was one of two individuals who signed up households for donations through Southern Pine Electric Cooperative.

Escambia County President Joey Moffett states, "Ginny has raised the quality of community relations between Appleton Fire Department and the Appleton community. In addition to her work in the fire department in the community, this has been accomplished by hosting an annual Easter Egg Hunt, a Christmas Parade and volunteering to assist in fundraisers outside of her department."

Competition Results

The Competition this year was held at Battleship Park on Mobile Bay and competition was strong, with competing teams encouraging each other as the firefighters ran each of the events. There were ten departments competing this year, and although all the teams made heroic efforts, the Thomasville VFD Competition Team came away with the gold, winning all three of the scheduled events for the seventh straight year.

2002 Firefighter of the Year

William "Bill" M. Hamman was selected as AAVFD 2002 Firefighter of the Year, not for any heroic deed, but instead for his selfless, day-to-day participation in the Spanish Fort Fire Rescue department in Baldwin County.

Bill coordinated several department projects, including assistance with construction oversight on Station 2, maintenance and painting of all hydrants in the jurisdiction, and keeping business pre-plans up-to-date. For his efforts, he was recognized as "Rookie of the Year". In addition to his "extra" duties, Bill routinely attends weekly training drills and a majority of department work details. Bill has been a top responder since joining the department, making 60% of all responses. Bill has also dedicated an additional 79 service hours in maintenance and prevention activities.



Bill is a single parent raising two teenage daughters. He is active with his church, community and school programs. He is also part of the American Red Cross Disaster Response Group. The ARC recognized him for his volunteerism at a recent awards ceremony. He was chosen by his fellow firefighters as Baldwin County's Firefighter of the Year in 2001.

Baldwin County President Joby Smith states, "I have personally known Bill since he moved to this area, and from day one, he became very active in volunteer work, both in his community and throughout the county." Chief Roger Few added, "Heroes walk amongst us every day, and most go unrecognized. Bill is a hero in every sense of the word, not because of heroic acts he has performed, but because of his day-to-day acts of selfless service to his community."



IMPORTANT NOTICE TO FIRE PREVENTION GRANT RECIPIENTS



As required by the Wildland Fire Prevention Grant Program, a final report of your fire prevention program must be submitted to the Alabama Association of Volunteer Fire Departments no later than September 30, 2002.

The following information is required:

- 1. A narrative of what was done on your project.
- 2. How the funds were actually spent (with receipts).
- 3. Number of man-hours your department put into the project.
- 4. Approximate number of people to whom your program was presented.

We thank your department/association for taking part in this fire prevention grant program provided by the Alabama Forestry Commission. Preventing fires saves the volunteer fire service time, money and lives.



Obligations

Obligation -*n*. a duty, contract, or promise that compels one to follow a certain course of action.

When we became firefighters and/or emergency medical technicians, we assumed an obligation to help those in our communities who were in need. Maybe we didn't think much about it when we joined our department, but we did make a commitment to our citizens. How well are we meeting those obligations as a firefighter or EMT?

Across Alabama we have hundreds of AEDs that are now in the hands of volunteer firefighters and EMTs. These units were placed in the fire departments as a

result of the work done by Senator Tom Butler, the Alabama Department of Public Health, the Alabama Association of Volunteer Fire Departments, the EMS Regions, and others. Work is continuing to try to get these units in every volunteer fire department (that wants one) in the entire State. We have a ways to go, but we are still working on the job.

Each department that has received one of these AEDs also received additional obligations to their community. Did you realize that each of these units come with their own particular obligations to which you and your department are responsible?

What are some of these obligations or responsibilities?

You are obligated to make sure that:

• you are trained in CPR and the use of your unit at least every two years.

• you can operate the machine quickly and effectively.

• your department is paged out when there is a need.

• the unit is delivered to a scene where it is needed in a timely fashion.

• the unit is ready to be used – the battery is good and you have at least two good sets of pads with the unit.

When you received your AED, your department agreed to meet the above obligations. If you are lax in any of these, then you are not fulfilling your obligation to your family, your relatives, and the members of your community.

I would hate to try to explain to a person that had just lost a loved one that the reason we could not save their mother, father, grandmother, or grandfather was because the battery was dead in the unit, or that someone failed to replace the pads in the unit after its last use, or that we forgot how to use the unit. I hope that none of us ever have an obligation to do something like this.

Farm Bill to Benefit Rural Firefighters

On May 13, President Bush signed a \$190 billion farm bill (HR2646) that not only guarantees higher subsidies to farmers across the country, but also provides \$50 million over five years in funding for training scholarships for rural firefighters and EMS personnel and financial assistance to state and regional training centers.

The bill directs the U.S. Department of Agriculture (USDA) to provide at least 60% of this funding for competitively awarded grants to fund partial scholarships for training personnel in rural areas in firefighting, emergency medical services, and responding to hazardous materials and bioagents.

The legislation will also provide financial assistance to State and regional centers that provide training for firefighters and emergency medical personnel for improvements to the training facility, equipment, curricula, and personnel. There is a \$750,000 cap on each of these grants.

The USDA Rural Development Division, the agency that will be administering this program, will soon begin putting together the regulations. Funding will not be available until at least next Fiscal Year, which begins in October.
