# 14th Annual Rural Community Fire Protection Institute Dinner & Vendor Show • Saturday, March 29, 2003

Mark Your Calendars! 29 March 2003, Rural Community Fire Protection Institute dinner, vendor displays and training sessions. This year, your Board of Directors has put forth an extra effort to have something for everyone. There will be three training sessions in the afternoon.

**1.** Mr. David L. Heaven, FBI agent from the FBI Bomb Data Center, will address the issues emergency services personnel should consider when working emergency operations, with particular emphasis on incendiary type devices.

Mr. Heaven has been a Special Agent for the FBI since 1977 and has worked in Alexandria, Virginia; New York, New York; and Huntsville, Alabama. He has been an FBI Bomb

Alabama. He has been an FBI Bomb Technician since 1985, when he attended the Hazardous Devices School at Redstone Arsenal. During his career his investigative specialties have been Domestic Terrorism and Foreign Counterintelligence. He worked on the New York Joint Terrorism Task Force as the Bombing Coordinator and, after transferring to Huntsville in 1991, served as Evidence Response Team Leader for the Birmingham Division.

In June 1997 Mr. Heaven was assigned to the FBI Bomb Data Center and was posted to the Hazardous Devices School as Program Administrator.

- 2. The Federal Emergency Management Agency (FEMA), Director of Grant Programs has agreed to participate in one of the training sessions addressing the FIRE GRANT program. This session should be of interest to all concerned with fire and EMS services in Alabama.
- **3.** Meth Labs and their Hazards Meth labs use chemicals that are hazardous to any person coming in contact with them.

Some of the chemicals associated with labs are:

Denatured alcohol Acetone Red Phosphorous Iodine Crystals Sodium Hydroxide (Red Devil Lye) Solvents (lighter fluids, coleman fuel) Hydrogen Chloride Gas (peroxide and salt mixture)

Anhydrous Ammonia

Lithium Metal

Sodium Metal

Firefighters coming in contact with these chemicals during a fire would be very hazardous to their health. During lab operations phosphine gas is produced, conversion of red phosphorous to white phosphorous, toxic vapors of iodine and have exothermic/incompatible reaction of red phosphorous and iodine.

These chemicals cause eye, nose, throat, and lung irritation. They can also cause severe

burns, respiratory depression, unconsciousness and even death.

Because of potentially life threatening and chemically contaminated environments it is essential firefighters learn to detect and report, secure the scene and remove anybody that is unprotected.

A special for this year's program will be give-a-way drawings during the day. Throughout the day the RCFPI will hold drawings, for re-certified air packs. At press time of this newsletter we have 8 to 12 re-certified air packs for the GIVE-A-WAY Program. Most of these drawings, if not all, will be held during the training sessions.

# **Houston Co. Assn. Forms Honor Guard**

The Houston County Volunteer Firefighters Assn. recently formed an honor guard made up of the fire chiefs of the 17 departments. The association purchased the uniforms at a cost of \$5200. We had asked for volunteers and discussed for several months with little interest before deciding to appoint the chiefs. The need was highlighted a couple of years ago when one of our firefighters (age 37) suffered a fatal heart attack at his workplace. The AAVFD


Honor Guard was already obligated to another funeral in north Alabama. The family was very disappointed since the firefighter, a single man was such a dedicated volunteer.

As of yet, we haven't trained very much. We purposely will begin slowly, mainly serving as casket bearers and fold and present the flag, then hopefully ease into other areas of the service. We have also dedicated a "wall of memory" in our association training center for photo/plaques of our fallen brothers.

# The Smart Way To Fight Fire

For the past two years this association, with the help of the Alabama Forestry Commission, has provided grants to the volunteer fire service for Wildland Fire Prevention. I am happy to announce that for the year 2003, we will continue this grant program. This association has received an additional \$100,000.00 from the Forestry Commission for this important program.

I will ask the grant committee to meet in January to review this project. Expect some major changes in the grant application. A review of our grant program by the University of North Alabama and The Northwest Alabama Council of Local Government have recommended five project areas for our Wildlife Fire Prevention Program. (1) Education, (2) Public Involvement/Public Information, (3) Advertisement, (4) Public Notice and (5) Promotional

Literature. An addition to the above changes, the Forestry Commission has extended the grant-reporting period for this association to December 2003. This will allow those who receive grants to prepare your program in time for National Fire Prevention Week, which is October 5-11. Another benefit by extending the time to December will give departments additional school days for your program.

This has been a learning process for forestry, the county association/volunteer departments and this association. The grant committee noticed many mistakes made by those who received the Wildland grants for 2001-2002. The most common of these were purchasing items not related to Wildland Fire Prevention. I do expect the grant committee to establish strong guidelines in the area. You must keep in mind this program is designed for **Wildland Fire Prevention** and not **Fire Safety**. As both fire prevention and fire safety are important to us as volunteers, this grant deals only with Wildland Prevention.

In today's fire service we are faced with two major problems. First, an increase in the number of emergency calls each year. Second, a continuous decline in volunteer fire-fighters in most departments across our state. As we are working hard to recruit volunteers, we must work equally as hard in reducing fires. One person from your department can present a fire prevention program at the time and place of your choosing. On the other hand, to fight a fire you must provide many firefighters, thousands of dollars in equipment, and the timing is not of your choosing. The reality of any fire prevention program is, it is the "smart way to fight fire."

# **VOLUNTEER FIRE SERVICE IN AMERICA**

Volunteers comprise 73% of firefighters in the United States. Of the total estimated 1,064,150 volunteer and paid firefighters across the country, 777,350 are volunteer.

Communities served by Volunteer Firefighters depend on them to be their first line of defense for many types of emergencies. Volunteer firefighters are summoned to a wide array of emergencies across the country every day including fires, emergency medical incidents, terrorist events, natural disasters, hazardous material incidents, water rescue emergencies, high-angle and confined space emergencies, and other gen-

eral public service calls. The public relies on Volunteers to be their first line of defense in these emergencies. Volunteers spend an enormous amount of time training to prepare for these emergencies.

The majority of fire departments in the United States are volunteer. Of the total 26,354 fire departments in the country, 19,224 are all volunteer; 3,845 are mostly volunteer; 1,407 are mostly career; and 1,878 are all career.

Services contributed by Volunteer Firefighters save localities across the country an estimated \$36.8 billion per year.

Grove Hill VFD, Clarke County, Fire Chief Don English and Firefighters Jeremy Welch, Gary Johnson and Chris McVay attended the National Fallen Firefighters Memorial Service in Washington, D.C., October 5th and 6th, the beginning of National Fire Prevention Week. A "Sea of Blue" was created by 100,000 firefighters dressed in blue Class A uniforms, walking in the Processional led by the New York bagpipers. Family members of the fallen firefighters rode on chartered buses in the procession down Pennsylvania Avenue. Over 440 firefighters died in the line of duty in 2001; three honored were from Alabama.

The nominated individual must be a member of a volunteer fire department that is a current member of AAVFD. No form is necessary. Recommend the firefighter and tell why you think he or she should be recognized, attach statements by others, if you wish.

These awards are not for valor. Information about a heroic act may be included in some recommendations, but these acts are not necessary to be eligible for one of these awards. There are many far-above-average personnel around this state who have not yet been singled out for their volunteer service to their communities. This is your opportunity to recognize that person for the many significant contributions that they have made.

Nominations must be mailed to the AAVFD office no later than <u>April 30th</u>. The awards will be presented at the annual Conference in Fort Payne in June.





# ACCIDENTS? INJURIES? Are Our Members Covered?

If you are currently providing Workers Compensation (W.C.) for your members you are probably thinking your members are covered for anything that would happen while they are doing fire department activities. While W. C. is without question the best insurance you can buy to protect your members it does not cover everything.

Here's a true and false pop quiz with answers that may surprise you.

- 1. While attending a meeting at the fire department, one of your members suffers a heart attack and is rushed to the hospital. He or she will be covered by Workers' Compensation, medical and disability benefits.
- 2. A volunteer earning \$600 a week misses one month of work because of a back injury he incurred while rolling hose. Workers' Compensation will replace all of his lost income.
- 3. The Chief asks his sister, who is not a member of the department, to help hang decorations in the fire depart-

- ment building for an upcoming fundraising event. The ladder gives away and she falls, receiving a concussion. Workers' Compensation will cover her medical bills and provide disability income.
- 4. During a fire, a volunteer firefighter suffers from smoke inhalation and because of it misses two days of work from his regular job. Workers' Compensation will provide disability income for the days missed.

# Unfortunately, they are all false.

- 1. Workers' Compensation typically doesn't provide benefits for heart attacks that occur in non-emergency events. Even in emergency situations it is a long drawn out process.
- 2. Nope ... more like two-thirds of his paycheck, which is the maximum benefit Workers' Compensation provides for disability. In Alabama the most W. C. will pay is \$479 a week so members with higher incomes could actually receive less than two-thirds of their income.

- 3. Only listed members of the organization are generally considered eligible to receive Workers' Compensation benefits.
- 4. Alabama has a three-day waiting period. If your disability is under three days you will not receive a penny disability. If you are disabled for more than twenty-one days Workers' Compensation will pay the first three days. The medical bills incurred will be paid.

Surprised? Relying solely on Workers' Compensation can be costly. Again, let me emphasize that WORKERS' COMPENSATION is the best insurance available for fire departments. Most accidents that cause injury are covered under Workers' Compensation, and the medical benefits that are provided by Workers' Compensation make it the best buy available. This article is just to let you know that Workers' Compensation by itself will not cover all your claims.

# 2003 STATE CONFERENCE INFORMATION

We hope you will take advantage of the many resources and attractions throughout our county, including Little River Canyon National Preserve, Historic Sequoyah Caverns, Buck's Pocket and Desoto State Parks. 





# Almost...

Legislation to expand Federal benefits for line-of-duty deaths nearly made it through the U.S. Congress. The House of Representatives passed the Hometown Heroes Survivors Benefits Act, but the Senate failed to act on it in the last days of the 2002 session.

The legislation would have expanded the Public Safety Officers' Benefits Act to include deaths from heart attacks and strokes suffered while on duty, or within 24 hours after participating in a training exercise or responding to an emergency. The current law allows benefits only if the death is a direct result of a personal injury

sustained in the line of duty. The current federal benefit is over \$260,000.

The National Fallen Firefighters Foundation and other fire service organizations will work with firefighters survivors to develop a grassroots strategy for passage of the Hometown Heroes bill and broader state benefits.
