



Volunteerism is just about a thing of the past. When one does happen along, he or she is given a 2-way radio or pager, turnout gear, a map of the area where the VFD responds, and Wham! They are a full-fledged fire fighter. Some departments have 90 day and 6 month probationary periods. Some are so thankful to get the help, it's "Welcome aboard and be careful out there!"

Some departments have SOP's, most do not. Therefore, with little or no training, the new volunteer is on his own, responding to all types of emergency incidents that place their lives on the line each time the tone goes off.

Training is important! Fire emergencies don't care if you are a "paid" or "volunteer" fire fighter. The risks and hazards are the same for each. The 160-hour Certified Volunteer Firefighter course is available through the Alabama Fire College or in the field at your department.

Our association is looking hard at an entry-level minimum number of hours of training during the first year. We are considering a 40-hour First Responder course and 24-hour Firemanship I that will teach the new volunteer CPR and AED, emergency medical treatment, SCBA, EVOC, pump operations, hose, ladder, and building structure basics.



RIBBON CUTTING AT NEW PERDIDO VFD

The new Perdido Volunteer Fire Department was officially opened Saturday. A short ceremony including a ribbon cutting was held at 11 a.m., with lunch served to the public afterward.

Mary Sells and Hugh Harris, members of the Alabama Association of Volunteer Fire Departments, were on hand for the flag presentation.

Perdido VFD Chief Web Bush said the new facility is a great improvement over the old one which housed only two trucks. It is large enough to serve as a community center as well. Chief Bush said the facility is available for community and private events - with the understanding that alcoholic beverages are not allowed on the premises.

The department has 22 volunteer firefighters, with 12 active. Other officers are Assistant Chief Bubba Bossard, Captain Steve White, and Lieutenant C.P. Hall.

2009 DUES AND AD&D INSURANCE RENEWALS

The fire department membership dues for the year 2009 and the 2009 AD&D insurance renewal/application notices were mailed the first week in October. If your department joins through the county association, the notice was sent to the county president. Insurance notices were sent to the chief of each department.

The AD&D insurance policy remains one of the least expensive policies that can be purchased for volunteer fire-fighters. In the event a fire-fighter is disabled or dies in the line of duty, this policy would provide some financial assistance to the family in paying bills. As an extra bene-

fit, each policy holder will receive a quarterly issue of "The Volunteer" to keep abreast on the latest fire service news in the state, as well as national events.

Annual membership dues are payable January 1, 2009. If you did not receive your dues notice or if you are not a member and wish to join, contact the Montgomery office at 334-262-2833 or 1-888-972-2833, and we will send you information on the benefits associated with AAVFD membership, such as eligibility for the insurance coverage, student scholarships and the Wildland Fire Prevention grant.

News of the Volunteer Fire Service from across Alabama

Lauderdale County Association of Volunteer Fire Departments sponsored their annual Life and Safety Day in Florence on October 11, featuring Fire Fighter Competition, truck displays, Children's Fire Safety House, Kid's Fire Challenge, free giveaways, food and fun.

Marley Mill VFD, Dale County, conducted an EVOC 16-hr class. EVOC Instructor Chauncey Wood taught the class attended by 15 fire fighters. He was assisted by Clio fire fighter & EVOC Driver Freddie Childs.

Clio VFD, Barbour County, hosted the course "Service Testing: Pumpers, Hydrants, Hose" on December 13th. "Service testing is an integral part of fire service equipment operation and maintenance", said Course Coordinator Chauncey Wood. Head Instructor Wayne Stell emphasized that fire ground operations will at times require fire apparatus pumps, fire hose and fire hydrants to operate at the maximum performance level. Therefore, it is imperative that the fire suppression forces know the actual operational conditions and limitations of the fire fighting equipment within their arsenal.

The service testing course provided students from Baker Hill, Blue Springs, Clio, Cowikee, Green's Crossroads and Texasville VFD in Barbour County and Ariton and Marley Mill VFD in Dale County with a working knowledge of service testing requirements and procedures. The course further surveys testing principles, examines and demonstrates various pieces of test equipment and reviews and illustrates the test records required in each equipment category.

Marley Mill VFD, Dale County, hosted a Safety Smoke House Class on October 30th.

Green's Crossroads VFD, Barbour County, hosted Propane Emergency Training on Nov 7-8. Attending were fire fighters from Louisville, Clayton, White Oak, Baker Hill, Texasville, Clio, Cowikee, Springhill VFD and Green's Crossroads.

Forest Home VFD, Butler County, sponsored a Wildland Fire Prevention and Awareness program October 18th with Smokey Bear products for kids, brochures and other items for adults. This event was made possible by the Wildland Fire Prevention Grant awarded by AAVFD, in partnership with the Alabama Forestry Commission.

LYNN VFD HONORS FORMER CHIEF

Donny Cagle passed away August 19, 2007 at the age of 55. He had been a member of the Lynn Volunteer fire Department in Winston County for approximately 28 years. Donny was better known as Motor. He served in many positions during that time, including Fire Chief for numerous years.

Donny was the type of person who never sent you into a dangerous situation, "He would lead you in". If you weren't trained for the situation, you stayed away from it. Safety for everyone was first. If didn't matter if we were toned out for someone who only needed a few minutes or for 12 hours, Donny was always there and glad to help. He always found ways to improve the department in every aspect.

Donny retired for a short time, but remained as the department advisor. He came out of retirement at the request of other LVFD members. When Donny arrived on scenes after his short retirement, he would always ask the person in charge where he was needed. The reply would always be the same, "You need to take charge." He would just smile and say, "You're doing a great job!"

He remained an active member until his death. Motor will continue forever be in the hearts and memories of everyone that knew him.

In October 2007, Lynn's new station was finished and dedicated in memory of Donny Cagle. One year after his death, Donny's family started a "Firefighter of the Year" program. They placed a large plaque with Motor's picture on it at the station. Each year, the fam-

ily presents a personal plaque to the Firefighter of the Year and adds their name to the plaque. This year's Firefighter of the Year award went to LVFD Fire Chief Derreck Cagle.

LANDMARK DESTROYED

Flames engulf the historic childhood home of former Governor George C. Wallace in Clio in Barbour County on September 7th.

Firefighter's fought hard to keep the fire from spreading to surrounding properties. There was a huge turn out to try and save the historic landmark home, but to no avail. The home that was built in the 1900's out of fat lightwood couldn't be extinguished.

The house was a total loss with firefighter's being called back several times during the next week due to the house sparking back up. Some of the elderly people said it was due to Governor Wallace being called the "fighting little Judge" in his earlier years.

The house was privately owned and had been renovat-

ed some 20 years ago. The home was listed on the Alabama Register of Landmarks and Heritage in 1975 and a designated site on the Barbour County Governor's Trail Scenic Byway.

Barbara took care of her family, stayed active in church, continued in the woman's auxiliary, opened up a Family Barber shop, and became the only woman Mayor of Lynn.

She also served in the capacity of Fire Chief. During a fire run, she fell and broke her back, but continued to help because they needed her, not telling them she was hurt.

She continues to help this community. She remains active in her business, woman's auxiliary, church organizations, prepares and delivers food, WMU, Civitan Club and all other areas where she can help others.

There are not enough words to express our love and appreciation for Barbara. She's a very "Special Lady".

Angel Janae Cagle is 9 years old. She hasn't accomplished everything Barbara has yet, but she is off to a good start. She's one of Lynn VFDs youngest fund raisers. Her grandfather helps her with one of the best lemonade stands around. They are also known for homemade fudge and peanut brittle.

Angel has been taught to give. She has six family members in the department: her parents, both sisters, a brother-in-law, and her brother is a Captain, or L-3. She calls him "Bubba". Angel needed a number for fund raisers, so she was "unofficially" given L-3 and 1/2, which she loves.

On the day Angel was Barbara's special customer, she wanted her hair cut, but not because of a new style. She had finally talked her parents into letting her donate her hair (that had never been cut before) to help other kids. Barbara cut 21" off Angel's hair to send to "Locks of Love".

Angel left Barbara's just as beautiful and full of love as she went in.



FIRE FIGHTER RULING / ROADWAY VEST

On November 21, 2008, the FHWA issued an

interim final rule revising the Worker Visibility rule (23CFR 634) to create an exemption for the firefighting community. This interim Final rule allows firefighters or other emergency responders working within the right-of-way of a Federal-aid highway and engaged in emergency operations that directly expose them to flame, fire, and/or hazardous heat. materials to wear retroreflective turn-out gear that is specified and regulated by other organizations, such as the National Fire Protection



Association. Firefighters or other emergency

responders working within the right-of-way of a Federal-aid highway and engaged in any other types of operations shall wear high-visibility safety apparel as defined in this rule. The FHWA decided to issue this interim final rule to address safety concerns raised by the fire fighting community. The interim final rule was published in the Federal Register today and goes in effect on November 24, 2008.






FEMA GRANTS HELP DEPARTMENTS PURCHASE NEW TRUCKS

BRIERFIELD VFD HOSTS 2ND ANNUAL WATER ON WHEELS PROGRAM

One of the many challenges for rural volunteer fire departments is access to adequate water resources to fight fires. Often, if water hydrants are scarce, firefighters must use alternate resources such as creeks, lakes, or rivers. This process of transporting water from non-traditional resources is called water shuttling. Recently, over 50 firefighters from several area volunteer fire departments gathered in Montevallo, Alabama for water shuttle training.

Called Water on Wheels, this program included a day of

classroom instruction, followed by a day of live situation training. According to Brierfield Fire Chief Spruce McRee, who led the training exercise, water shuttle is a method that's been used in rural communities for years, but when the fire is extensive, multiple fire departments may be required on the scene. "By training together, we are all better prepared for mutual aid situations." Last year, Maryland-based instructor Larry Davis, an expert in the water shuttle process, led the training. When Davis passed away earlier this year, the firefighters who took his course wanted to keep the momentum going.

"We are all very appreciative of the knowledge that Larry Davis shared with our firefighters, and will continue to pass that knowledge on to our neighboring volunteer fire departments, so that we are all better prepared to protect our communities," said Chief McRee.




The Association, with the help of the Huntsville Fire & Rescue Color Guard, performed the Last Alarm for 4 fam-
