

FROM THE AAVFD PRESIDENT'S

Whereas you do not know what will happen tomorrow. For what is your life? It is even a vapor that appears for a little time and then vanishes away. James 4:14

Everybody I know is a procrastinator to some degree. We may not put off everything, but we certainly do put off some things that are either distasteful or difficult. The Bible teaches us that we have no guaranteed number of days on this earth. Any moment of life might well be our last. That fact should teach us to appreciate the days we have and to make the best use of each moment.

If there is some act of kindness you think to do, then do it while you can. If there are loving words to be spoken or written to friends or family, then do it while you are able. The time for regret is terribly long. Our past President and my predecessor, Johnny Leroy Alberson said to me on many, many occasions; "make each day count!" We should feel compelled to do the things we ought to as we have the opportunity.

The regular session of the Alabama Legislature began Tuesday, February 7. The first few weeks were fairly tame. Thus far, most of the attention in both the house and senate has been on trying to deal with the fact that our state is, to put it in plain terms, "broke as a haint." More than \$300 million in windfalls supporting the general fund won't be available this year. The citizens of Alabama will be badly hurt. It may be an understatement to say that it's not a good time for the "faint of heart" to be in leadership roles in state government. It will take a courageous stand by those in power to say to the citizens of Alabama that more revenues are needed for both the education and general fund budgets. There are reports of a total reorganization of state government, and while that might be a good thing, it's not the final word on our states financial problems. Governor Bentley has prorated all state agencies that receive general fund monies by 10.62 percent. This immediately affects OUR partner, The Alabama Forestry Commission and cuts to our RCFP grant check for the 2012 fiscal year. We can no longer afford to ignore the reality that revenues must be found. It's my opinion that increasing sales and income tax rates shouldn't be an option. That leaves property tax increases and closing corporate tax loopholes as the most logical sources of new revenues. It's high time for our legislators to step up to the plate; tough times call for tough decisions but it's an opportunity for them to lead our state in the right direction. I fully believe Governor Robert Bentley is the man with the courage required to take on this battle. But if he does, he will need lots of help!!

Representative Richard Laird, Our fire caucus co-chair has introduced a constitutional amendment that will let the voters decide on whether or not to increase the state property tax by half a mill. **HB 275** would raise about \$28.1 million a year. It

raises the state property tax from 6.5 mills to 7 mills. Eighty percent of the money would go to the already strapped general fund for the non-educational services that would help programs such as our rural community fire protection VFD's, Seniors Meals on Wheels, Mental Health and Medicaid to name a few. Ten percent would go to the annuity fund for the firefighters and ten percent would go to the peace officer's annuity and benefit fund. For owner-occupied homes, the proposed tax increase would cost an extra \$3 a year for a residence appraised at \$100,000, \$5.50 a year for \$150,000 home and \$8 a year for a \$200,000 home. Contact your member of the house and ask for their support for HB275. "Remember, VFD's save a lot of property across the State, by doing so we save a lot of claims that would be going to insurance companies!"

Tough times - or opportunity? The situation is what it is and it won't change on it's own. "Do more with less," is often heard. With challenge comes opportunity! I'm a firm believer in the old adage that "what gets recognized gets repeated." First responders pride themselves in doing the job right the first time so it wont have to be done a second time! OUR AAVFD legislation and other legislation that the Alabama joint fire council voted to support is moving on the fast track in both the house and senate. Committee meetings have been wall to wall and now we are at the half way point of the 30 day sessions. (See page 6 for a complete list of our bills and othen.)

In closing, I want to offer our heartfelt condolences to Elaine Alberson and sons Garrow and Lloyd and their families in the untimely passing of our past President Johnny Alberson. Mr. Johnny passed away on Valentine's Day, February 14th at the young age of 72. Knowing Mr. Johnny as I do, he's sitting in the drivers seat of the heavenly fire truck with the pedal to the metal! "Well done, good and faithful servant." Matthew 25:21.

2012 AAVFD LEGISLATION

- **1.** <u>HB1/SB9 WORKERS' COMPENSATION INSURANCE:</u> Require the Commissioner of Insurance to regulate the maximum annual payroll per fire fighter or rescue squad member for the purpose of setting workers' compensation rates for volunteer fire departments of rescue squads, or combination departments.
- 2. <u>HB185 TAX EXEMPTION:</u> Provide sales tax exemption (excluding school taxes) for AAVFD and County Volunteer Fire Associations, AL Association of Rescue Squads, County Rescue Squads and Fire Districts that do not come under the auspices of their County Commission.
- 3. <u>HB186/SB326 PROVIDE FOR AL FORESTRY COMMISSION LOANED EQUIPMENT DISPOSAL BY VOL-UNTEER FIRE DEPARTMENTS:</u> Amend Section 9-3-18 to allow a fire department to dispose of state-owned property obtained through the AL Forestry Commission in any manner it chooses.
- **4.** <u>HB188 AL FIREFIGHTERS ANNUITY AND BENEFIT FUND:</u> Amend to provide for a voluntary annual fee (\$3), less an administration fee (not to exceed 3% of revenues remitted to fund), on each property and casualty insurance policy issued.
- **5. HB275 AL FIREFIGHTERS ANNUITY AND BENEFIT FUND:** Constitutional amendment to levy additional one-half mill annual state ad valorem tax to be distributed evenly between AL Firefighters Annuity Fund and AL Peace Offices Annuity Fund
- **6.** <u>HB316/SB336 SPRINKLER SYSTEM PERMITS:</u> Allow State Fire Marshal to issue permits to certified potable water single family dwelling fire protection sprinkler contractors.
- 7. <u>HB335/SB134 ESTABLISH ALABAMA FIRE COLLEGE INDEPENDENT STATUS:</u> Clarify that the Fire College is an independent institution of postsecondary education under the Personnel Standards Commission. Also provides for representation of AAVFD and AL Association of Fire Chiefs on the Commission.
- **8.** <u>HB366 LINE OF DUTY DISEASES:</u> Would authorize blood and saliva testing of any person who exposes a law enforcement officer, firefighter, first responder, or corrections officer to a contagious, infectious, and communicable disease during the course and scope of the law enforcement officer's official duties.

SUPPORTED LEGISLATION

- 1. <u>HB5 EXPANDS STATE FIREFIGHTER DEATH BENEFIT:</u> Provide death and disability benefits due to certain occupational diseases for firefighters employed by the state; and to provide that the state must prove by a preponderance of the evidence that the condition was caused by some means other than the occupation disqualify the fire firefighter from benefits.
- 2. <u>HB11 HEALTH INSURANCE FOR LODD SURVIVING SPOUSE/DEPENDENTS:</u> Would allow surviving spouse or dependants to continue to be covered by the SEHIB plan and the cost would be paid from the State Treasury.
- **3.** <u>HB89 STATEWIDE E-911 BOARD:</u> Would replace existing Commercial Mobile Radio Service Board, provide for establishing and collecting a single statewide emergency telephone service charge replacing all existing charges, and provide for the distribution of funds to local communications districts and commercial mobile radio service providers.
- **4. HB187 AL ASSOCIATION OF RESCUE SQUADS:** Allow minimum voluntary \$2 income tax contribution by check off on annual income tax returns.
- **5. HB579 FIREWORKS:** Provide for permits and fees issued by the State Fire Marshal and grants authority to regulate the sale of fireworks and to seize and destroy illegal fireworks.
- **6. SB410 AL ASSOCIATION OF RESCUE SQUADS:** Add \$3 (refundable upon request) to each state and local ad valorem tax bill on real property.

The Alabama State Troopers Aviation Unit recently practiced rescue operations with Eutaw VFD and Greene County EMS units. The training simulated wilderness rescues, like those of a wounded hunter, injured logger or fisherman.

GOVERNOR BENTLEY ADDRESSES DESIGNER DRUG "SPICE" HEALTH CONCERN




A public hearing was held September 19, 2011 addressing the emerging health concern regarding the designer drug "Spice" or "Herbal Incense", and the rash of suicides following the use of this drug.

AAVFD President Chauncey Wood and Third Vice President Dan Hopkins accompanied Steve and Lori Murphree and Joe Clark, accompanied by Cleburne County firefighter Matt Carlisle, as they met with Governor Bentley. Both families lost their sons, who committed suicide after smoking "Spice".

According to the American Association of Poison Control Centers, more than 6,700 calls were made to poison control centers nationally in 2010 and in the first seven months of 2011. The Poison Control Center at Children's of Alabama reports receiving 67 calls from persons exposed to "K2" or "Spice" since October 2010.

Three victims were children 6 to 12 years of age, 15 were teenagers and 22 were in their 20s. 76 percent were male. Of these callers at least 56 were treated for toxic exposure to synthetic marijuana in hospital emergency rooms. Complaints have included hallucinations, nausea and vomiting, paranoia, and increased heart rate. Two families who live in neighboring counties in the area represented by Vice President Hopkins are each mourning the loss of their son, a victim of "Spice"

At the time, "Spice" could be obtained online, at conven-



ience stores/gas stations, head shops and tobacco shops. Although chemicals found in similar products were banned nationwide earlier this year, chemical compounds had been tweaked to bypass the law.

In response to the seriousness of this emerging and dangerous designer drug, Governor Bentley issued an executive order banning the sale of "Spice". State, county, and city law enforcement officials immediately began removing this from the shelves of all stores statewide.

WILDFIRE ON THE STATE LINE


Firefighters found out on a Monday afternoon in March that weather conditions were making it a chore to keep fires under control.

More than 75 acres burned near the Alabama-Mississippi state line in western Colbert County. Low humidity and gusty winds increased the risk of wildfires through northwest Alabama.

Although the area has had a lot of rain lately and the ground is wet, there has been a lot of wind and the vegetation is dried out. When vegetation is dry, humidity is low, and winds are strong, a fire can get out of control in the blink of an eye, and it can take a long time to bring it back under control.

Firefighters from Alabama and Mississippi, along with Forestry and a fire crew from the Natchez Trace Parkway, battled the forest fire for more than eight hours. Smoke would be seen for more than 15 miles.

As the fire became too large for firefighters to control with fire trucks and hand tools, Forestry Commission bull-dozers were called in plow trenches around the blaze to contain the fire.

JOINT FIRE COUNCIL EDUCATION DAY

The Alabama Joint Fire Council Education Day was held on the Capitol grounds in Montgomery on March 7th, in conjunction with the Alabama Fire College and Personnel Standards Commission. Legislators were treated to a barbque lunch, while being given a glimpse of the technology available for firefighter training at the Alabama Fire College.

The Joint Fire Council is supporting legislation that the firefighter community believes will allow the Alabama Fire College to fulfill its mission to meet the needs of the fire emergency service community and operate more efficiently. This legislation has been unanimously endorsed by AFC & PSC Task Force (established by Representative John Merrill), AAVFD, AAFC, AFFA, and PFFA.

HB335/SB134, sponsored by Representative John Merrill and Senator Gerald Allen, respectively, clarifies that the Alabama Fire College is an independent institution of post-secondary education operated under supervision and control of the Alabama Firefighters' Personnel Standards Commission. The legislation clarifies lines of authority and eliminates duplication. It also provides for representation by AAVFD and AL Association of Fire Chiefs on the Commission.

SB134 was voted out of the House Education Policy Committee that afternoon, with many firefighters attending the committee meeting. This legislation passed by a vote of 95 to 0 on April 5th . It now awaits Governor Bentley's signature.


