





Sherry Garner Memorial Award

Candy Reeves has been a volunteer with the Johnson's Crossing Volunteer Fire Department in Cullman County for going on 21 years. She and her husband both have been a very committed part of their community.

Candy joined the fire department in February of 1987, along with her husband who presently serves as chief, and on an annual basis runs 95-98 percent of all calls the department receives. Candy is presently secretary and treasurer of the department, Emergency Medical Technician Captain, a Captain in the fire department, and pretty much is what the firefighters call our "Ms. Chief. She has served in the past on the Board of Trustees.

She is a certified firefighter and is presently working on becoming a certified fire instructor. Candy oversees a lot of the training for the department, as well. Candy not only keeps the department finances running smoothly, but she deals with all of the department's problems. She keeps the department going, and that is why they call her "Ms. Chief".

There is nothing on the fire grounds that this lady will not do or has not done. She packs out to go in a burning residence, just like the rest of the firefighters. She grabs the end of the nozzle, attacks the fire and will be the last one to sit down to take a break while there is something that needs to be done or taken care of on the fire scene or wreck scene or medical call. Whatever the need is, Candy is there to lend her helping hand and to guide and direct the department as a whole in the direction that the department needs to go.

Johnson's Crossing had 3 house fires in a 2-year time span that

consisted of burn fatalities. Candy has been at all 3 of those fires, and she has had to not only deal with the burden of a fatality on a scene, but be there to deal with those families who just lost their loved ones. After all is said and done, Candy will then make sure that all of her personnel are cared for. She makes sure that they are able to deal with everything they have just seen or dealt with, whether it be that burn fatality or a severely injured person in a wreck. Her patients are very dear to her, as well as their families.

There have been a lot of family meals that she and her husband have left to go and help someone else that was in need. She donates so much time to keeping the department running smoothly. You can go to her for anything, and she can either give you the answer or she will work until she can give you an answer.

So much that she does is behind the scenes that many never know that she is doing it and taking care of situations. This includes all those trips to the bank, the post office, and the job of taking care of the department finances, and the problem-solving before the issues become problems.

Johnson's Crossing firefighters call Candy Reeves "Our Hero", the "Ms. Chief". "Candy is special to us, and we are proud to have her taking care of all the things that she does for us."



Firefighter of the Year Award

Lt. John A. Register has been both a volunteer and career firefighter for over 20 years. He has been with Banks Volunteer Fire Department in Pike County for 5 years, Troy Fire Department for 17 years and Pike County Fire & Rescue Unit for over 20 years.

John's firefighting career began when his cousin's mobile home burned. As a result of this loss, John and his cousin, Fred Davis, Ronald Dawkins and many others in the Meeksville community formed the Meeksville Volunteer Fire Department.

He was very active in organizing the Pike County Firefighter Association and getting state funding for the department.

In 1985, John became a volunteer with the City of Troy. By this time, he realized that he wanted to be a career firefighter, so this became his goal. On May 16, 1991, John started his career with the Troy Fire Department. One of his dreams had come true at the age of 35. Seventeen years later, he is a Lieutenant.

In 1993, a call was received for a person trapped in a corn combine. When John got there, he saw that it was an 18-year-old boy whose leg was trapped in the combine. John stayed with him until he got to the hospital. Sadly, his leg was so damaged that it had to be removed. If you ask him what is the hardest



thing about being a firefighter, he will say, "Those calls can be really tough, especially when children or teenage people are involved. Being a father and grandfather, it can really hit home fast."

Since John is a father and grandfather, he makes sure that his children and granddaughter know about fire safety. In 2004, his granddaughter, at the age of 4, saved the life of her father, mother and sister from a house fire. She remembered what she had learned about fire safety from her Paw-Paw and saved them

In 2004, John was nominated for the "Ronald W. Dawkins Memorial Firefighter of the Year". As he received the award, he stated "This is a great honor because Dawkins was the one who first encouraged me to get involved in volunteer firefighting. From then on, firefighting just got in my blood, and it's been there ever since."

In 2006, John was named the Firefighter of the Year by the American Legion at their convention in Mobile.

John was nominated by his son, who says, "John is a loving husband and father. He has three children and one grandchild. He is also my father and that is why I know so much about him."

He was assigned to the high angle and hazardous materials teams and worked extensively with law enforcement as a medical support officer. He holds ProBoard certifications for Fire Officer IV, Fire Instructor III, Fire Inspector III, Safety Officer, and Rescue Technician: Rope, Confined Space, Structural Collapse, Trench, and Surface Water. Allan has taught numerous courses pertaining to firefighting, emergency medicine and hazardous materials and has previous experience as a trauma and flight nurse.

Allan received his paramedic certificate and undergraduate degree in nursing from the University of Alabama at Birmingham and holds a Master's degree in Public and Private Management from Birmingham-Southern College. He is a member of the International Association of Firefighters, Professional Firefighters of Alabama, Alabama Firefighters Association, and Alabama Association of Fire Chiefs. He and his wife Kelly live in Hoover with their two sons.



EUELL HODGE HONORED BY HOME COUNTY

The Cullman County Firefighter Training Center has been dedicated to President Euell Hodge.

Gold Ridge Fire Chief Joe Golden presented the dedication plaque to Hodge on Saturday on behalf of the Cullman County Association of Volunteer Fire Departments. Hodge is president of the association.

Golden said Hodge spent many hours in the planning, designing, funding and building of the training center.

The plaque says association members express their sincere appreciation to Hodge for his dedication to the volunteer fire-fighters.

"His initiative in working with the Cullman County Commission resulted in securing the funding and location to make these facilities become a reality. Through these efforts, firefighters are and will for many years be better trained to meet the needs of the citizens of Cullman County," the plaque reads.

Before they become firefighters, individuals train for 160 hours at the center. They typically train four days a week for four hours a day and even come from surrounding counties, said Hodge.

The center is also a practice center for firefighters from Cullman County and neighboring counties.

"We probably have the best one," in the area said Hodge.

Cullman Fire Fighter Deputy Chief Edward "Junior" Reinhardt Jr. said Hodge played a key role in getting the training center established.

"I love him. I think he's a great guy. He does a lot of work for the community," said Reinhardt. "We do work with them. We do use their training facility."

The training center is used for a variety of exercises, according to Reinhardt.

"There is a burn room where you can build a live fire for exercises," he said.

Reinhardt said search and rescue exercises were held at the site. Firefighters put on a self-contained breathing apparatus or air pack and go into a smoke-filled room. They locate the dummy and pull it out.

City firefighters drive their ladder truck to the center and set it up for an exercise. The ladder reaches 102 feet or nine to 10 stories high. High angle rope rescues are also practiced at the center, according to Reinhardt. Firefighters practice repelling off of a wall by using a tower at the facility.

The annual physical fitness evaluation program is conducted at the center every year as well. Critical training and testing also take place at the center.

Hazardous materials training is conducted, and fire truck pumps are tested at the facility as well.

The Clio and Brundidge Volunteer Fire Departments sponsored a 12-hour Alabama Fire College Accredited Propane Emergency Class for firefighters from the area on July 20-21.

The purpose of the training was to prepare volunteer firefighters to safely handle propane gas fires. The Alabama Propane Gas Association donated a propane simulator to aid in the training of emergency responders in propane emergencies. "The simulator allows the firefighters to train on a tank that is actually on fire," said Mike McGough, Safety and Education Director of the Alabama Propane Gas Association. "They learn how to safely approach a propane fire, how to extinguish it or when to evacuate the area."


Chauncey Wood, AAVFD District 6 Director said that the training exercise required about 600 gallons of propane gas at a cost of more than \$1,200, which was provided by Brundidge Cooperative Propane, along with the manpower for the two-day

Jimmy Conner, Alabama Fire College, said any time there is a propane gas cylinder in close proximity to a fire, it must be watered down and kept cool to keep the gas from expanding and possibly exploding. "That is called a bleve, boiling liquid and expanding vapor explosion," he said. "Those are very rare, but they do happen and firefighters need to know how to safely handle that kind of situation."

Conner said all propane gas cylinders and bob-tail (delivery tanks) are equipped with a safety valve that allows the pressure to escape. "When a firefighter hears that hissing sound, he knows that the tank is doing what it is suppose to do," he said. "However, when a firefighter hears a scrapping metal sound, it's time to run."

"We've recently had two propane fires in Clio so that is some indication of how important this training is," Wood said. "We learned a lot in the classroom, and then we were able to put what we learned into practice."

NAPIER FIELD VFD

The Napier Field VFD was established in 1974 and has a coverage area of approximately 28 square miles in southeast Dale County, which includes the communities of Napier Field and Grimes.

The 6 certified firefighters, one with EMT certification also, and 9 non-certified members run a 1991 E-One pumper, a 2006 GMC brush truck, and, a 1973 Chevrolet P30 van as a support vehicle. The fire department has an ISO rating of 6/8 and responded to 30 calls last year.

After many years of holding several fundraisers per year, the department has a small reserve, which allows them to operate on funds received through tobacco taxes and modest donations, either from individuals or from the community.

Fires don't kill American firefighters as much as heart attacks

government study has found that sudden cardiac death is the leading cause of death in the line of duty for firefighters.

Traumatic injuries from motor vehicle crashes while responding to an emergency were a close second for volunteers, said the report, which appeared in the April 28 Morbidity and Mortality Weekly Report, a publication of the U.S. Centers for Disease Control and Prevention.

The real message, though, is that these causes are preventable and that things can be done to reduce the risk.

An earlier study had reported that, for the past 25 years, heart attacks have typically caused the most deaths among firefighters. However, as awareness of heart disease and prevention has increased, the number of deaths attributed to heart attacks has dropped by more than one-third, the report found.

There are 800,000 volunteer firefighters in the United States and 300,000 career firefighters. For the new study, researchers analyzed data from the U.S. Fire Administration, which keeps a database of all on-duty firefighter deaths based on death certificates and fire department interviews. On-duty firefighter deaths include all those that occur within 24 hours after a response to a call.

From 1994 to 2004, 610 volunteer and 368 career firefighters died while on duty, 97 percent of them male. The median age was 47 years for volunteers and 44 years for career firefighters.

Among career firefighters, 39 percent of deaths were caused by heart attacks; 29 percent from other causes, such as burns, cerebral vascular

accident or drowning; and 20 percent by asphyxiation (mostly from being caught or trapped).

Half of the deaths among volunteer firefighters were from heart attacks and 26 percent from motor vehicle-related trauma. Almost three-quarters (73 percent) of motor vehicle-related deaths were caused by crashes, 30 percent of which involved private vehicles. Eighty percent of the crashes occurred en route to calls, while 5 percent occurred during returns.

In both categories of firefighters, most heart attacks occurred among people aged 45 to 54. The majority were attributed to stress and overexertion for both volunteers (98 percent) and career (97 percent).

The study also provided details of two particular fatalities, one of a volunteer and one of a career firefighter.

On July 28, 2003, two volunteer firefighters responding to a trailer fire sped down a two-lane road at about 80 miles per hour in a privately owned vehicle with emergency lights on. The speed limit was 55. The driver lost control when the vehicle drifted off the pavement. He was killed, and the passenger sustained serious injuries. The fire department required that firefighters obey local traffic laws.

In the second case, a 51-year-old career captain collapsed while responding to a fire in the attic of a two-story dwelling. An autopsy revealed that the man had cardiovascular disease. He had also suffered a heart attack 13 years prior and had undergone angioplasty of his right coronary artery. According to the article, under these circumstances, the captain should have been issued work restrictions.





REHOBETH VFD DEDICATES NEW STATION

A Dedication Ceremony marked the end of a half a million dollar project and the beginning of a new facility to better serve Rehobeth residents and Houston County citizens in the surrounding area.

It started two years ago when a storm felled a pine tree into the roof of the old Rehobeth Fire Station, causing extensive structural damage to the building. With the old facility having outgrown its ability to properly house the equipment and serve as a training facility for the department, the thoughts were to try and build a more modern and structurally sound building.

John Parrish, the department's Equipment and ISO officer teamed up with Phillip Santoro of North Star Engineering to tackle the project. The existing land was not large enough to house the needed facility. One feature that was highly desired was pull-through bays for the equipment. The current facility would only allow backing in the equipment after a run. Parrish pointed out that backing in the vehicles was a major cause of injury and death to fire and rescue personnel.

The Town of Rehobeth supplied the land for the new facility by way of "in kind" services. Houston County provided almost all of the site work, with the exception of material costs, some of which jumped during the two years the project was under way. An example of sky-rocketing costs was asphalt, originally planned at \$17,000. By the time it was needed, costs had

jumped to \$27,000. The structure was funded with a grant from the U.S.D.A. Rural Development Board, with assistance from the local office, the County Commission, and U.S. Representative Terry Everett.

The new 5,600 square foot facility houses 1 Engine Truck, 1 dual-purpose brush and service truck, 1 "wild land" brush truck that can go almost anywhere (and, incidentally, Rehobeth's FIRST fire truck, and still in service!), a large training room, 2 offices (one for Fire Services and one for EMS services), a small conference room, a kitchen, and an equipment room. The unfinished upstairs will later be completed as a fitness and wellness area, funded by a grant.

The building is resistant to severe weather, having block walls reinforced with concrete and steel, and a steel roof fabricated with heavy steel beams and metal.

The new station is being called "Station One". The old facilities will still be used and houses a pumper truck and an ambulance. It is now called "Station Two".

The Rehobeth Volunteer Fire/Rescue department has twenty active members. The Fire Chief is Larry Strickland and Rita Parrish heads up the Emergency Services. Members are crossed trained and work in both services, as needed. The ambulances are served by four paramedics and several basic and advanced first responders.

THE BELL TOLLED

Chief Jim Pearce, Kinterbish-Brunson VFD, Sumter County, passed away January 25, 2007. Chief Pearce was 80 years old and still serving his department and community.

Chief James L. Hall, Sapps-Union Chapel VFD, Pickens County, died in a one-vehicle (POV) accident on July 26, 2007.

Donnie Cagle, Lynn VFD, Winston County, passed away from a heart attack after fighting a fire on August 19, 2007.

STATISTICS OF MULTIPLE FIREFIGHTER FATALITIES:

- In 2006, five firefighters died in the Esperanza Wildland Fire in California when the winds shifted and blew the fire over them.
- In 2006, four firefighters perished in a helicopter crash at a fire near McCall, Idaho.
- In 2003, eight firefighters lost their lives in a vehicle accident while returning from fighting wildland fires.
- In 2001 in New York, 343 firefighters perished in the Twin Towers in the 9/11 attack.
- In 2001, a crew chief and three rookies died when they were overrun by the Thirty Mile Fire in Washington State.
- In 1999, six firefighters died in a Worcester, Mass., warehouse blaze.
- In 1994, 14 firefighters died fighting a fire at Storm King Mountain, Colo., when they were overrun by a wildland fire.
